License required to operate a Drone commercially and must be renewed every 24 months by taking the recurrent knowledge test.

Logistics Technician

MSSC® requires that full Certified Logistics Technician (CLT)® Certifications be subject to recertification every five years.

The recertification process is point-based. Continuing education in a field related to logistics qualifies for recertification points. Individuals must accumulate at least 100 recertification points over the five years since certification to qualify for recertification.
